Bishop Conway Residence

WHAT

Bishop Conway Residence is an affordable supportive living model that offers housing to seniors age 65 and older. It consists of 7 studio apartments and 15 companion suites, each of which include a kitchen area with refrigerator/freezer and microwave, bedrooms (in companion suites only), bathroom and closets. Basic cable, blinds and central air conditioning are provided, complimentary furniture is available. Community space includes a comfortable TV area, laundry facilities, mailbox lobby, public restrooms, enclosed patio, and a community room. The residence is completely smoke-free.

WHERE

Bishop Conway Residence is located at 1900 N. Karlov Ave., Chicago, Illinois 60639.

FOR WHOM

Bishop Conway Residence is designed for senior citizens who meet the following requirements:

- Must be 65 years of age or older
- Complete a preadmission health and financial screening
- Must be without a primary or secondary diagnosis of developmental disability or serious and persistent mental illness
- Has income no less than the current maximum allowable amount of Supplemental Security Income (SSI)
- Has tuberculosis test that indicates the absence of active tuberculosis
- Is not participating in any other home and community-based services waiver

SERVICES

We also must regularly assess each resident's health and status and consult with the resident on an ongoing service plan that promotes health and wellness.

- Temporary nursing care
- Social/recreational programming
- Health promotion and exercise programs
- Ancillary services
- 24-hour response/security
- Personal care
- Laundry
- Housekeeping
- Maintenance
- Meals and snacks
- Medication oversight

HOW MUCH

Each Medicaid-eligible resident must have income equal to or greater than the current SSI and must contribute all but \$90 each month to the provider for lodging, meals and services. The \$90 is to be kept by the resident as a personal allowance to use as the resident wishes. Any resident receiving Supplemental Nutrition Assistance Program (SNAP) benefits (formerly Food Stamps) may be required to contribute those benefits to the facility as payment toward meal costs.
