# Senior Services Help Older Adults Thrive, at Home with Dignity

Amidst our beautiful fall foliage, Catholic Charities Senior Services continues to respond to the needs of seniors in Cook and Lake counties, ready in all seasons of the year to help nearly 80,000 seniors annually to thrive, in their homes, safely, comfortably, and with dignity. Keenager News asked three Catholic Charities leaders, Meisha Lyons, Vice President - Seniors, Angela Bailey, Associate Vice President - Service Coordination & Interim Vice President - Housing, and Umekia McIntosh, Senior Director - Care Coordination to provide an update on how Senior Services has progressed this year.

# What programs are currently offered in Catholic Charities Senior Services?

Senior Services currently offers Care Coordination, which is comprised of in-home services, adult day service, emergency home

response, automated medication dispensers and Choices for Care. We also provide Adult Protective Services, the ADRN (Aging Disability Resource Network), information and assistance, options counseling, Senior Health Assistance Program (SHAP), Illinois Senior Medicare Patrol (SMP), Senior Health Insurance Program (SHIP) and a Benefits Access Program, including the free transit card and license plate discount. Finally, we offer low-income senior housing and resident service coordination, caregiver resources, grandparents raising grandchildren services, drop-in senior center activities, and access to home-delivered, and congregate meals.

# Tell us more about Catholic Charities Drop-In Senior Centers!

Our ten drop-in centers offer a wide range of activities that promote healthy aging. Included are health education sessions, educational and exercise classes, card and board games, dance lessons, holiday celebrations, and more. Some classes are offered virtually for those who are homebound. Nutritious breakfasts and lunches are offered, and activities are open to all seniors

# Veterans Find Stability, and More on St. Leo's Campus

No one, especially those who served our country, should be without a home and yet, according to the most recent point-in-time count by the U.S. Department of Housing and Urban Development (HUD), which assesses the number of homeless people on a given night, veterans comprised approximately seven percent of all homeless adults in the country. As the director of Catholic Charities St. Leo's Residence for Veterans since 2014, it has been my privilege to help homeless veterans find stability with our unique, multifaceted approach.

The St. Leo's Residence is part of Catholic Charities St. Leo's Campus for Veterans, the first and only completed project of its kind in the nation. Located in Chicago's Auburn Gresham neighborhood, the campus includes the St. Leo's Residence, the Pope John Paul II Residence for persons with physical disabilities, the VA-operated Outpatient Clinic and Resource Center, and the St. Leo's Veterans Memorial Garden. In addition to subsidized rent, residents also receive comprehensive case management and supportive services, which are critical for helping them achieve and maintain stable housing and self-sufficiency.

Most people don't fully understand the challenges that the population we serve face. It is common to assume that PTSD (Post-Traumatic Stress Disorder) is the driving factor for their unhoused state, but the reality

is that veterans experiencing homelessness often faced numerous challenges *before* their military service, such as generational poverty, unemployment, limited education, family violence, mental illness, or substance use.

Many of the residents at St. Leo's served our country heroically and gained valuable skills during their military service. However, the combination of trauma from live combat together with unresolved past issues can make their transition to civilian life more difficult. This is why our approach to providing both housing and other supportive services is critical for their success.

The St. Leo's Residence consists of 141 fully furnished studio apartments, expansive common recreational space, a computer lab, fitness room, and multipurpose rooms for community meetings, including Alcoholics Anonymous and Narcotics Anonymous. In addition, each resident is assigned a master's-level case manager who helps them design an individualized plan to maintain stable housing, increase income through benefits and/or employment, and address other barriers to self-sufficiency such as substance use, mental health issues, trauma, level of education, and need for social or familial supports.

We advocate every day for our veteran residents, connecting them to other Catholic Charities programs or services from one of our community-based partners. Case managers work closely with the on-site VA clinic to help residents achieve the greatest possible level of health and self-sufficiency.

Sometimes it's hard for vets to accept help—they've been trained as soldiers, as protectors. Being vulnerable and accepting something for themselves doesn't come naturally. But when they take advantage of services such as those we offer at St. Leo's, they can truly soar. One of my most inspiring client relationships was a female resident, Debbie, who came to us from a domestic violence shelter and was suffering from a variety of issues including depression and anxiety. She was using a walker to get

around due to her injuries. In her own words, she had a "very dim view of life." In the beginning, she isolated herself in her room, but we didn't give up on her. Slowly she began participating in our programming. She kept on engaging and challenging herself. She went to her medical appointments and took advantage of the other services. She worked on paying her bills and cleaning up her credit issues. Through her own tenacity and a little help from us, she had a complete turnaround. By the time she left St. Leo's, she was able to buy her own home through a Chicago Housing Authority (CHA) program and was walking entirely on her own!

Witnessing the success of individuals like Debbie, and the dedication of my incredible staff who serve them, inspires me each day. It is tough work, but my team and I are continually amazed by the extraordinary resilience and fortitude of our residents. They keep moving forward, keep striving, even with everything they've confronted and continue to confront. It is truly a privilege to assist our brave veterans on their journey to find peace, stability, and a permanent home.

Veterans are very important to us at Catholic Charities. Each veteran has served in the United States Armed Forces, and it is our privilege to now serve them, if they need assistance. Catholic Charities offers two residential housing communities for veterans in Cook County: The Bishop Goedert Residence and the St. Leo's Residence, which is part of the St. Leo's Campus for Veterans (see Page 3). We also offer Supportive Services for Veterans and their Families, to ensure that veterans who are homeless, or on the verge of being homeless, receive emergency housing, case management and connections to benefits to which they are entitled. Our Veterans Employment Program offers job readiness training, resume writing assistance, mock interviews, and job placement counseling. We also network with employers who are especially interested in hiring veterans.

As Veterans Day, 2023 approaches, Keenager News asked participants in our Veterans Employment Program what they liked best about serving in the United States Armed Forces, and what they like best about being an American. Here is what they said:

# Holiday Traditions, Chicago Style

On June 28, 1870 President Ulysses S. Grant signed the Holidays Act, making Thanksgiving and Christmas (along with New Year's and July 4th / Independence Day) federal holidays. The first White House Christmas tree was decorated that year and since then, traditions from many countries have blended to make the Thanksgiving and Christmas holidays an American custom.

For Chicagoans, one of the oldest traditions begins with Marshall Field's *Walnut Room*. Originally called the South Grill Room, it was later renamed for the Circassian wood paneling imported from Russia encompassing the restaurant and floor. For 116 years, the annual 45 ft. Great Tree has been decorated with a new theme each year. Outside, for the last 56 years, the windows have displayed animated holiday scenes. The trumpets along State Street have been heralding in the holidays for 45 years.

Christmas Around the World has been an annual event at The Museum of Science and Industry since 1942. It originally had one single tree and has expanded to 50 trees circling the Grand Tree that stands four stories. These trees are dedicated and decorated in the holiday traditions around the world.

Twinkling lights have made the shortened days enchanting throughout the Chicagoland area. For 42 years **Holiday Magic at Brookfield Zoo** has welcomed guests on weekends in December to experience the zoo's holiday lights and music. This year there will be over two million LED lights! **The Magnificent Mile Light Festival** will celebrate its 32nd year

lighting the Christmas tree at the Wrigley Building while Grand Marshals Mickey and Minnie Mouse lead the parade along Michigan Avenue, switching on well over a million lights. Held the weekend before Thanksgiving, additional lights will come on at the Millennium Park tree and overhead with fireworks above Navy Pier. Lincoln Park Zoo Lights is celebrating its 29th year of lights with strolling costumed characters and traditional Victorian carolers from November to early January. Illumination Tree Lights at Morton Arboretum celebrates its centennial year and 10th anniversary of light and music exhibits. This year six new light shows will join the 12 favorites of light, sound and color from mid-November through early January. Lightscape at the Chicago Botanical Gardens is in its fourth year of illuminating paths and creating sparkle with many dimensional light displays from mid-November through the first week of January.

Along with the visual lights, melodies of the holiday season resound through carols and theatrical performances. The Goodman Theatre has been bringing Charles Dickens' A Christmas Carol to audiences for 45 years. Performances run from mid-November to the end of the year. Do It Yourself Messiah has brought together professional and amateur musicians to lead thousands of audience voices to perform George Frideric Handel's masterpiece for 43 years in two 90-minute performances in December at the Seventeenth Church of Christ. The Chicago Symphony Orchestra has been performing sing along holiday songs during several December performances of Merry, Merry Chicago since 2015. For outdoor strollers at Millennium Park, Caroling at the Bean (Cloud Gate Sculpture) takes place on Friday evenings, November 24th - December 15th from 6-7 pm as local choral groups lead the holiday sing along.

For the last 28 years, the two 1893 bronze sculptured lions outside the **Art Institute** have donned their Christmas wreaths the day after Thanksgiving. This day starts the extended Friday hours during the holiday season.

Not to be missed is the 18th Century Neapolitan Creche, showcasing the artistry and workmanship from Naples.

And or course whenever possible, enjoy travels to holiday attractions in the city on the Holiday CTA Train and Bus lines!

in the community. Catholic Charities staff ensure the wellbeing of all attendees and help seniors make connections to local resources.

# How do seniors apply to become a resident in one of our 19 apartment buildings?

Seniors (or their spouse) must be at least 62 years old. They must be able to fulfill rent by themselves or with whatever assistance they can provide privately, and households must meet income requirements as determined by the U.S. Department of Housing and Urban Development. Applications are available in person at residence security desks or by calling each residence.

# How do seniors today differ than those ten, twenty, or thirty years ago?

Seniors today are more self-sufficient, they are living longer, are more active, and are more technologically savvy. They are looking for more opportunities to stay socially engaged.

# Can you tell us about a senior whose life was enriched by Catholic Charities Senior Services?

Catholic Charities received a call that a 75-year-old Caucasian male lived alone, with no family nearby, and needed a

well-being check. When a case manager arrived at his home, the senior appeared disheveled. He did not have food, a working telephone, or electricity. His medical conditions included high blood pressure, COPD, arthritis, incontinence, and poor ambulation. The gentleman explained that his disability check stopped coming two months ago, and he did not know who to call. Catholic Charities Care Coordination and ADRN (Aging Disability Resource Network) units worked together to provide immediate assistance. ADRN staff contacted the Social Security Administration, and helped this gentleman submit the documents needed to reinstate his benefits. The Care Coordinator accessed Emergency Senior Services (ESS) funds to pay his overdue electricity bill and got him connected with a free cell phone through Safelink. A SNAP application was also completed to assist him with food purchases. The Care Coordination Unit went on to assess and qualify him for Home-Delivered meals, and homemaker services. He is now thriving safely in his home.

How long have each of you been working at Catholic Charities? Did you work with seniors before that? What do you like best about working with seniors?

Angela Bailey: "I have had the pleasure of

being with Catholic Charities for 32 years, 33 years in December, and have worked with seniors the entire time. I started as an intern and have worked in various roles throughout the years. My favorite part of working with seniors is positioning them to remain independent through our programs and resources."

**Umekia McIntosh:** "I have been with Catholic Charities for 19 years. This was my first opportunity to work with seniors in this capacity outside of helping family members and those at my church. I enjoy knowing that the work that I've done has allowed them to thrive better on a day-to-day basis."

Meisha Lyons: "I have been with Catholic Charities for 12 years. My first job after graduating from college was working as a care coordinator for seniors on the south side of Chicago. The best part of working with seniors is the blessing they provide us in sharing their wisdom. It is an honor."

# from The Recipe Box,

#### Company Eggs – Serves 12-15

#### **INGREDIENTS**

½ lb. grated Gruyere cheese Dash freshly ground pepper

4 T. butter 1½ T. dry mustard 1 c. whipping cream 12 eggs, beaten

#### **PREPARATION**

Spread cheese in a buttered 13x9x2 inch baking dish. Dot with butter. Mix in cream with seasoning and mustard. Do not whip. Pour ½ of cream mixture over cheese. Add beaten eggs, then remaining cream mixture. Bake at 325 degrees for about 35 minutes or until eggs are set. Serve from baking dish.

#### Chocolate Éclair Wreath – Serves 4

#### **INGREDIENTS**

1 c. water 2 pkg. vanilla instant pudding

½ c. butter or margarine 2½ c. milk 1 c. flour 8 oz. Cool Whip

4 eggs 1 t. vanilla 1 t. vanilla

Topping: 2 squares unsweetened chocolate, 2 T. butter

2 T. milk, 1 c. powdered sugar, 1 t. vanilla

For Holly Leaves: 4-6 oz. White chocolate, Green food coloring, Artificial holly leaves Garnish: cherries

#### **PREPARATION**

Heat butter and water to a rolling boil. Stir in flour over low heat until mixture forms a ball. Remove from heat. Beat in eggs thoroughly, one at a time. Spoon onto ungreased cookie sheet forming a large donut shape. Bake 45-50 minutes until golden brown at 400 degrees. Watch carefully. Cool.

Beat together pudding and milk. Fold in Cool Whip and vanilla. Cut cooled pastry in half, horizontally, then fill center of pastry with pudding mixture. Place top of pastry on top of filling.

Melt chocolate, butter, and milk for topping in double boiler. Add powdered sugar and vanilla. Add additional milk if needed for consistency. Drizzle on top of éclair.

Melt white chocolate and add green food coloring for leaves. While hot, spread on "veined-side" of clean, artificial holly leaves. Let it harden then gently peel off chocolate. Place white chocolate leaves and cherries on éclair to form holly.

#### Hula Hoop "Turns" 65!



If you're looking to give a toy this Christmas that has stood the test of time, look no farther than...the Hula Hoop!

The Hula Hoop is considered an ancient invention, with older versions being made from metal, bamboo, wood, grass, and vines. But the patent for the Wham-O corporation hoop is celebrating 65 YEARS this year! Wham-O's founders, Arthur Melin and Richard Knerr (left) started producing slingshots, then boomerangs, and other sporting goods before

they launched their plastic tube version of the Hula Hoop in 1958.

When Wham-O's Hula Hoop arrived in stores across Southern California that year, it was simply called, "Hula," after the hip-swiveling Hawaiian dance of the same name. It instantly became a huge fad across the United States, with an estimated 25 million Hula Hoops sold at \$1.98 in its first six months of production. Noisemakers and glitter have been added over the years, and some Hula Hoops have even been made to be collapsible. But the original idea of the Hula Hoop remains a favorite for kids of all ages, and adults who want to feel like a kid! This simple toy continues to be a fun pastime and competitive sport around the world.

#### **OTHER HULA HOOP FACTS:**

- Hula Hoops became a worldwide craze in the 1960's.
- Fitness experts have consistently agreed that the Hula Hoop can provide a fun and effective, full-body workout.
- The Hula Hoop has been inducted into the American National Toy Hall of Fame.
- Japan once banned the Hula Hoop because the rotating hip action seems indecent.
- In 2017, a gathering in Taiwan set a new Guinness World Record for the most people simultaneously Hula Hooping: 4483 participants
- In 2018, an Australian performer named Marawa Ibrahim set a Guinness World Record by simultaneously spinning 200 Hula Hoops around her body.
- Also in 2018, a team in Russia created the largest Hula Hoop ever recorded, measuring 16.22 meters in diameter.
